The aim of this research ; 1) to find out the values of character education contained in the Novel by Andrea Hirata ; 2) to find out the dominant character education values in Andrea Hirata's novel. The research approach used in this study is a descriptive qualitative approach with the type of library research. This study uses qualitative analysis, namely analyzing data related to the problem being studied, then selected based on logical thinking to avoid errors in the data analysis process. The results showed that the character education values contained in Andrea Hirata's novel are: *Amar Ma'ruf Nahi Mungkar*, Pray on time, have an honest attitude, cultivate a disciplined attitude, work hard, have an independent attitude, foster democracy in oneself, have a social care attitude and have a responsible attitude.

INTRODUCTION

1) Religious Values in the novel Laskar Pelangi by Andrea Hirata

Quote 1. "..... Then right under the sun, there were bald Arabic letters which later after the second grade, after I was good at reading Arabic letters, I knew that the writing reads amar makruf nahi mungkar, which means: enjoining the good and forbidding the evil." That is the main guideline for Muhammadiyah members. Those words stuck in our hearts until we grew up" (Hirata, 2005:19)

Qoute 2. "..... Live only from the teachings of the Qur'an, hadith and Sunatullah, that is the main guidance of Muhammadiyah. God willing, after you grow up, you will be bestowed with lawful sustenance and a sakinah life companion." (Hirata, 2005:230)

2) The Value of Honesty in the Novel Laskar Pelangi by Andrea Hirata

Quote 3. "....Another trait of Sahara that really stands out is her incredible honesty and true respect for the truth. He doesn't lie. Even though he was threatened with being thrown into the lake of blazing fire, not a single lie would come out of his mouth" (Hirata, 2005:53)

Qoute 4. ".... On my chest was a round blackish red mark, a trace of omniscience. When my mother asked me about the sign, I did not move, because the lessons on Budi Pekerti Kemuhammadiyahan every Friday morning did not allow me to lie to my parents, let alone my mother". (Hirata, 2005:57)

3) The Value of Tolerance in the Novel Laskar Pelangi by Andrea Hirata

Quote 5." Chiong Si Ku or prayer grabs are held every year. A lively event where all Chinese citizens gather. Not infrequently his children who migrated home for this event. Many other entertainments are attached to this religious ritual, such as areca nut climbing, merry-go-round, and Malay orchestra, which attract everyone to visit. Thus, this event can be called a medium where the four main components of sub-ethnic groups in our village: the Chinese, the Malays, the islanders in sarongs, and the Sawang people gather". (Hirata,2005:171)



4) The Value of Discipline in the Novel Laskar Pelangi by Andrea Hirata

Qoute 6." It can be said that Lintang often risked his life to pursue education, but he never missed a day. Eighty kilometers to and fro by bicycle every day. Never complained" (Hirata, 2005:64)

5) The Value of Working Hard in the Novel Laskar Pelangi by Andrea Hirata

Qoute 7." After a day of teaching, Mrs. Muslimah continued to work receiving stitches late into the night to earn a living, supporting himself and his younger siblings" (Hirata, 2005:26)

DISCUSSION

1. The values of character education depicted in the novel of Laskar Pelangi

a. Religious Value

By looking at and examining each sheet of *Laskar Pelangi* Novel, the researcher can give a response that there are several things that can be learned from *Laskar Pelangi* Novel in terms of religious values. By looking at quote 1 in the exposition of the research results, it can be analyzed that the first teachings received by Ikal and his friends were guidelines for religious life, namely the Qur'an and Hadith. It teaches about the holy book Al-Quran which was revealed by Allah to the Prophet Muhammad SAW that every Muslim must learn and practice.

b. Honest

Honesty is behavior based on efforts to make oneself a person who can always be trusted in thoughts, words, and actions, both towards oneself and others. Excerpt 6 teaches the reader that an attitude of appreciating the truth is the meaning of honesty. As in quote 6, it is Sahara who remains in her stance to remain honest in any condition. Although his honesty will lead to disaster for himself, the attitude of the Sahara who respects the truth deserves to be used as a guide.

c. Tolerance

Tolerance is an attitude of mutual respect between each other with all the differences whether race, ethnicity, religion, culture. In the novel also found the attitude of tolerance described by Andrea Hirata as in quote 9 can be understood when an event where all Chinese citizens gather, so many people from various ethnicities gather to visit and enjoy the event. Tolerance is very important because with mutual respect, social life will be peaceful, peaceful and harmonious.

d. Discipline

Discipline is an attitude or action that shows orderly behavior and obeys various existing rules and regulations because it is with this discipline that will lead a person to success. A quote in the novel that describes discipline as in quote 10, in that quote Lintang never skips school, his attitude shows that Lintang is a disciplined student. Even though Lintang had to travel a very long way from home to her school, she still went to school diligently.



e. Hard work

Based on the data exposure, it can be seen that in the *Laskar Pelangi* novel also found educational values, namely hard work described by Andre Hirata where in a quote 12 it can be seen that Mrs. Mus is a very extraordinary hardworking figure, after teaching Mrs. Mus does not immediately rest but continue to work in an effort to provide for himself and his family.

2. The dominant character education values in the novel

From several values of character education that the researchers found, the researcher can draw a conclusion where the dominant values for character education described by Andrea Hirata in the novel *Laskar Pelangi* are:

a. Religious values

Religious values are one of the dominant values for character education described by Andre Hirata in the novel *Laskar Pelangi*, which teaches about how a person stays away from everything that is prohibited by religion, such as prohibiting shirk as described in the following excerpt.

"...Remember this young man, there is no wisdom whatsoever from polytheism, what you get from these occult practices is an error that is getting deeper and deeper because of the multi-layered nature of shirk. The devil fancies you every time you fan those incense coals."(Hirata, 2005:231)

b. Polite

Politeness is also an important attitude, especially in the formation of student character. Andrea Hirata also describes a fragment in the novel *Laskar Pelangi* as follows:

"...After loading the groceries into the like of a pickup, the iron-boned man received some money. He thanked me with a polite bow and then returned to his shop." (Hirata, 2005:300)

c. Discipline

Discipline is one of the important things in life, especially in education, therefore Andrea Hirata in the novel also describes the values of discipline as in the following excerpt:

"...It can be said that Lintang often risked her life to study, but she never missed a day."(Hirata, 2005:64)

"...Even though his house is the farthest away, when he comes he is the earliest."(Hirata, 2005:74)

CONCLUSION

Based on the results of research that has been done by the author, it is known that in relation to education, it appears that the values of character education have the same orientation, namely to form a better person to become a good citizen. So it can be concluded that there is a relevance between the values of character education in the novel by Andrea Hirata and education at Madrasah Ibtida'iyah.



The values of character education contained in the novel by Andrea Hirata are: amar ma'ruf nahi mungkar, pray on time, have an honest attitude, cultivate a disciplined attitude, work hard, have an independent attitude, foster a democratic attitude in oneself. , have a socially caring attitude, and have a responsible attitude and the dominant character edcucation values contained in the novel of are: religious value, polite and discipline.
